HOW TO BECOME A CHESS VENDOR

 To subcontract with a current prime visit our CHESS IT e-mart at https://chess.army.mil/ and select "Hardware" (on the main menu bar), select "Hardware Contracts" and then select the contract vehicle you are interested in.
- Once you select a contract you will be provided with a list of vendors. Select the "Contract Details" link for the vendor you would like to subcontract for and you will then be taken to their individual contract page. Scroll to the bottom of that page and under Vendor POC you will see contact information. Please contact the vendor directly
- to request a subcontracting opportunity.
